- ❖ The AOA will be retitled referencing the Law 2017.
- ❖ 7-3a Ambassador will be referred to as Head of Mission.
- ❖ 9-3a Quorum indicates 30 minutes before an AGM, we propose to change to 10 minutes as everyone is on a tight schedule.
- ❖ 10-11a no change, however BOD need to be very aware if there are any conflicts of interest between Chamber and their line of business this needs to be declared and approved by the BOD.
- ❖ The Chamber Management will update board minute formats, that in the event of any vote or motion presented at a board meeting, it is clearly highlighted in the minutes the result of such a vote.

Throughout the year, the British Chamber organised a variety of events, including training workshops, webinars, briefings, networking gatherings, and signature occasions.








BCCM Golf Tournament 2024

Chair's Highlights of Membership and Trade

Trade & Business Fair in August 2024 with 72 booths for 68 companies attended by over 250 visitors with 110 guests at the end of the Trade Fair Networking Event.

Partnered with Smart Power Myanmar and Yoma Bank to deliver a renewable energy event on solar power financing attended by 150.

Exports: UK exports to Myanmar rose by 5.8% (£165 million). Imports: UK imports from Myanmar dropped by 49.8% (£217 million).

Despite various challenges in the market, we have successfully maintained 211 memberships and issued 252 British Club Membership Cards in 2024.

Focus on membership retention, engagement, and collaboration to develop innovative and appealing activities. As of November 2024, we successfully recruited 45 new memberships.

During the peak membership renewal period in August 2024, 85% of members successfully renewed their memberships, while 5% opted to drop out, and 7% have not responded.

Trade & Business Services

- ❖ In 2024, BCCM played an active role in strengthening business connections, networking, creating platforms for businesses to grow, and building partnerships with local trade associations. For example, signing an MOU with MYEA, attending MYANWEN AGM, meeting the President and Secretary-General, UMFCCI.
- Provided business service assistance to UK and local companies in their business expansion and market exploration.
- ❖ Taken on a role as Co-Chair and Secretary of BiSEA (Britain in Southeast Asia), an organisation that represents close to 7,000 members across the British Chamber of Commerce Network in Southeast Asia.


